### GRANT OF SHARE OPTIONS

This announcement is made by Country Garden Holdings Company Limited (the “**Company**”) pursuant to Rule 17.06A of the Rules Governing the Listing of Securities (the “**Listing Rules**”) on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”).

The board of directors (the “**Board**”) of the Company hereby announces that on 26 March 2021, the Company has offered to grant to two executive directors of the Company, namely Mr. YANG Zhicheng (“**Mr. YANG**”) and Mr. SU Baiyuan (“**Mr. SU**”) (collectively, the “**Grantees**”) of 644,397 share options (“**Mr. YANG’s Share Options**”) and 901,113 share options (“**Mr. SU’s Share Options**”) respectively, with a total of 1,545,510 share options (collectively, the “**Share Options**”, each a “**Share Option**”) under the share option scheme adopted by the Company on 18 May 2017 (the “**Share Option Scheme**”) which, subject to the acceptance of the Share Options by the Grantees, will enable the Grantees, upon full exercise of all such Share Options, to subscribe respectively for 644,397 shares and 901,113 shares with an aggregate of 1,545,510 new shares of HK\$0.1 each (the “**Share(s)**”) in the share capital of the Company for the subscription price per Share Option set out below (all subject to adjustments under the terms of the Share Option Scheme in accordance with Rule 17.03(13) of the Listing Rules), such Shares respectively representing approximately 0.0029% and 0.0041% and in aggregate approximately 0.0070% of the issued share capital of the Company as at the date of this announcement.
